<u>SPONSORSHIP CORNER:</u>

Continued from December issue....

Must the newcomer agree with everything the sponsor says?

If the sponsor's ideas sound strange or unclear, the newcomer had better speak up and ask questions. Theirs is suppose to be an easy, open relationship, in which both parties talk freely and honestly with each other.

The A.A. program is simple, but it didn't seem that way at first. Often, we learned by asking questions, at closed meetings or—most especially—in conversations with our sponsors.

What if the sponsor is unavailable when needed?

It is the whole A.A. program—not the individual's sponsor—that maintains the newcomer's sobriety. Sponsorship is just the best way we know of introducing a newcomer to the program.

So we have many resources when we are unable to contact our sponsors. We can telephone other members; go to an A.A. meeting; phone or visit the nearest A.A. office or clubroom for sober alcoholics; read A.A. books or pamphlets or our magazine, the A.A Grapevine, to find answers for almost any problem troubling us at the moment.

May a newcomer have more than one sponsor?

Many feel it is best for a newcomer to have only one sponsor. Choosing one sponsor helps to avoid the precarious practice of a newcomer going from sponsor to sponsor seeking the advice he or she *wants* to hear.

However, some newcomers benefit from more than one sponsor. Here is the newcomer shares in a wide range of experience and hears a great variety of ways to use the A.A. program. In addition, this is a means of averting the crisis in the preceding question—it is unlikely that the two or more sponsors would be unavailable at the same time.

May a newcomer change sponsors?

We are always free to select another sponsor with whom we feel more comfortable, particularly if we believe this member will be more helpful to our growth in A.A.



Some questions and answers about anonymity

A.A. members as well as many people outside the program are sometimes puzzled about how to put the principle of anonymity into practice. Some of the most frequently asked questions about both personal anonymity and the anonymity at the media level:

Personal anonymity

Q. After I tell my loved ones about my A.A. membership, should I ask them not to disclose this information to anyone else?

A. This is entirely a personal matter, but it is usually best for all concerned to let the A.A. member decide who shall be told and when.

Q. If relatives , friends, and business associates comment on my improved appearance and functioning after I become sober, should I tell them I'm in A.A.?

A. Members of the immediate family and close friends are usually pleased to learn about an alcoholic's membership in A.A. As for business associates, it might be best simply to say that you've stopped drinking and postpone decision about disclosing your membership until after you have been in the fellowship for several months.

Q. What should I do if I meet old acquaintances at A.A. meetings?

A. You need to ask them to protect your anonymity; they are there for the same, or similar reasons. They will generally respect your privacy and you in turn, should respect theirs.

Q. What if I see public figures at a meeting?

A. Like everyone else, public figures should have the protection of anonymity to the extent that they desire it.

Q. I know that I should not reveal the names of members that I learn in A.A. meetings, but what about other personal information?

A. It is understood by A.A. members that personal disclosures made in A.A. meetings are to be treated as confidential. For example, if friends outside the program are acquainted with some of your A.A. friends and know of their membership, you should be careful not to violate confidences picked up at meetings, however harmless they may appear at the time.

Q. Should I tell people who seem to have a drinking problem about my A.A. affiliation?

A. This is a personal matter. However, the spirit of the program is one of sharing and a recent study of A.A. members shows that a high portion of them joined the fellowship through another member. Before reaching a decision about such matters, most members find it helpful to discuss them with sponsors or A.A. friends.

Q. Should I reveal my anonymity to my boss so that I can attend A.A. meetings regularly?

A. Asking for special favors because of A.A. membership is not in the spirit of anonymity Tradition.

Tradition Seven: Every A.A. group ought to be fully self-supporting, declining outside contributions.

Treasurer: A.A. groups are self-supporting through their members voluntary contributions. Passing the basket at meetings usually covers the groups monetary needs, with enough left over so the group can do its fair share of supporting the local Intergoup (central office), the general service district and area and the General Service Office.

No on is obligated to contribute, but most people do. Those who can are generally willing to put a bit extra into the basket to make up for those who can't. Group funds ordinarily are earmarked for such services as:

- Rent
- AA literature
- Local meeting lists, usually purchased from your nearest intergroup office (central service), district or general service area committee
- Coffee and refreshments
- Support of all A.A. service entities, usually on a monthly or quarterly basis.

Treasurers generally maintain clear records (a ledger book is helpful) and keep their groups informed about how the money is taken in and how it is spent. They make periodic reports to the group and post financial statements quarterly. Problems can be avoided by keeping group funds in a separate group bank account that requires two signatures on each check.

A.A. experience shows that it is not a good idea for groups to accumulate large funds in excess of what is needed, plus a prudent reserve, an amount to be determined by the group conscience. Group troubles may also arise when extra-large donations-in money, goods or services- are accepted from one member.

The conference-approved pamphlet "self support- where money and spirituality mix" makes suggestions as to how groups may support A.A. services.

Additionally, G.S.O., area and sometimes district committees and your local intergroup accept contributions from individual A.A. members-not to exceed \$2,000.00 in any one year. Bequests or in-memoriam contributions of not more than \$2,000.00 are acceptable on a one-time basis, but *only* from A.A. members.

Some members celebrate their A.A. anniversary by sending a gratitude "gift" to the General Service office for it's world services-usually one dollar for each year of sobriety. For additional information talk to your general service representative or write to G.S.O.
